Resolutions passed in AGM, Karnataka circle held on 04.07.2021

1. AAO to AO Promotion:

It was decided that the matter can be addressed to CHQ with a request to the authorities concerned to explore the possibility of promotion on the same line as was done in AAO cadre.

2. Transfer List:

It was decided that a suggestion may be made to the CHQ to insist on accommodation of eligible AAOs to their Home circle or place of their choice.

Further in respect of request transfer, CHQ to be requested to take up the transfer of officers to their Home circle with periodical reminders.

- 3. <u>JTS Promotion</u>. CHQ to be requested to take up the matter on priority with the competent authority for periodic conduct of DPCs and facilitate the promotion to JTS of Sr.AOs.
- 4. <u>Restructuring of Gr'B' Cadre:</u> It was suggested that the restructuring of Gr'B' cadre to be completed before taking up the restructuring of Gr'A' Cadre.
- 5. Entry Pay to AAOs: CHQ to be requested for speeding up the process of obtaining favourable orders from MOE by getting the information called for by MOE from DoT/DoP expedited.
- 6. <u>Issue of 3% increment:</u> In view the latest instructions issued by DoP Hqrs withdrawing the benefit of increment on promotion to AAO cadre, I was decided to request CHQ to request the competent authority to address DoP&T to review its MACP orders and till the receipt of reply to keep the recovery and refixation in abeyance.
- 7. Confirmation of AAOs: In the recent list issued by DoP Hqrs, confirmation orders in respect of AAOs who have completed the induction training and SAs who have completed probation has been issued. It was suggested that in respect of all other AAOs who are yet to complete the Induction training, the completion of orientation programme should be taken as the basis for issue of confirmation as the reason for non completion of induction training is administrative.
