The pending issues/unresolved agenda items of last meeting are as below:--

1. AAO to AO regular promotions,
2. Implementation of Group A status to Sr.AOs incumbents of IP&TAFS cadre with attendant benefits with effect from 09.04.2009 in view of Hon'ble Supreme Court judgement as Hon'ble MOC has already approved it in September, 2020. OM for classification of Group A status may be issued immediately on same line of CGA,DAD & CAG as well as local officiating arrangements in different grades of IP&TAFS Group A-held in abeyance of recent SEA-I wing OM dated 21.01.2021 and Local officiating from Sr.AOs to STS may be continued as available before issue of this OM,
3. Conducting of AAO LDCE exam in 2022

Following important & current cadre issues are also submitted for sympathetic consideration:--

1. Abnormal delay in holding of JTS DPC/promotions,
2. Down gradation of 30-35 posts JAG posts in STS Grade on urgent functional requirement basis,

The whole IP&TAFS cadre is expecting high heights & better implementations of new schemes of DOT-DOP departments as well as numerous new achievements in career advancements of IP&TAFS cadre under your dynamic leadership, sir.
