Subject : Constitutional Amendment resolved in the 5th All India Conference of P&TAFOA held at Bhubaneswar from 23rd June 2022 to 25th June 2022 - reg

Respected Sir,

The 5th All India Conference of 'P & T Accounts and Finance Officers Association' was held from 23rd June 2022 to 25th June 2022 at Bhubaneswar, Odisha and, as per powers vested to the General Body of the All India Conference in Part I Article 9 read with Article 7(b) of Part II (CHQ) of the Constitution, the General Body of the AIC, being the Supreme Body of the Association has resolved and unanimously passed the following Constitutional Amendment, with effect from 24.06.2022:

Constitutional Amendment No. 1:

Existing Provision [Under Article 13(a) of (Central Headquarters) of the Association]	Amended Provision
<i>The Central Secretariat shall consist of the office bearers of the Central Working Committee stationed at Central Headquarters, and headed by President or General Secretary</i>	The Central Secretariat shall consist of members of the Association from all over India and headed by a Chairperson (Central Secretariat) nominated from among the members of the Central Secretariat Team, which will function in co-ordination with the President or General Secretary of the Association.
<i>Note : The Central Secretariat at its discretion may co-opt not exceeding two members from local Circle Branch provided that the total strength of Central Secretariat after such co-option does not exceed five.</i>	Note : The Central Secretariat at its discretion may co-opt members of the Association from across India on need basis, provided that the total strength of Central Secretariat after such co-option does not exceed twelve (12).

The resolution is passed unanimously on 24th June 2022.

Constitutional Amendment No. 2:

The word "Meeting" wherever used in the Constitution will also have the same meaning as virtual meeting conducted online through 'Google Meet', 'Zoom', or any other electronic means.
