2- The period of deputation shall not exceed three years and will be initially for a period of one year and can be extended for two more years, on yearly basis, if required, in the exigencies of public service.

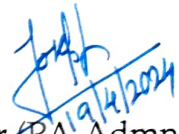
3- The above deputation will be subject to the terms and conditions of DOP&T OM No. and OM No. 6/8/2009-Estt (Pay II) dated 17.6.2010 and orders issued by Government of India from time to time in this regard.

4- The officers may elect to draw either the pay in the Level (in the Pay Matrix)/Scale of pay of deputation post or his/her basic pay in the parent cadre plus Deputation (Duty) Allowance thereon plus Personal Pay, if any as per the conditions of DOP&T OM No. and OM No. 6/8/2009-Estt (Pay II) dated 17.6.2010. The officers concerned should exercise their option within one month from the date of joining the deputation post.

5- The officers may be relieved of their duties at the earliest and join the deputation post within 30 days from the date of issue of this order. However, the officers involved in the works related to General Elections- 2024 in any capacity shall not be relieved till the election process is over.
