The promotion of the officer(s) as mentioned above is subject to the conditions that no disciplinary proceedings/vigilance case of the types referred to in the Department of Personnel and Training OM No. 22011/4/91-Estt. (A) dated 14.09.1992 and OM No. 22034/4/2012- Estt. (D) dated 02.11.2012 is pending against them and such case, if any, be referred to the Directorate, and no promotion be made. Further, if in respect of any officer some punishment is current, he/she should not be promoted/relieved on promotion and his/her case shall be treated as "Deemed to be under Sealed Cover" as per ibid DoP&T OM dated 14.09.1992. The same should be reported to this office immediately.

3. Heads of the office will communicate these orders and the place of posting to the officer(s) concerned immediately and obtain from them their acceptance of the offer of promotion within 10 days of the receipt of this memorandum and forward the same to this office. Acceptance of the offer includes the acceptance of the place of posting and no representation for change of place of posting will be entertained and no representation(s) need to be forwarded. The officers may be relieved within 30 days from the issue of this order by authorities concerned to report for duty on promotion at the place of their posting.

4. Refusal of promotion will lead to debarring the officer from promotion and financial upgradation of any kind till one year from the issue of this order. Disciplinary action can be taken against the officer for refusing to obey the orders of the Competent Authority. Officers refusing promotion shall be debarred from any officiating opportunity, which should be strictly implemented by the Heads of the CCAs/PAOs etc.

5. The above promotion order is subject to outcome of the various Court Cases pending against AAO LDCE 2018.

6. The pay of the officers on promotion will be fixed under FR-22.

7. The officer(s) already officiating in AO grade may be reverted to the AAO grade before promotion to the grade of Accounts Officer of IP&TAFS Group-B.
