


4. Posting within the circle will be made by the Head of the Postal Accounts Office/CCAs concerned.
5. The officer(s) named in Para (2) above are eligible to exercise the option as envisaged under FR 22(l) (a) (1) within the period prescribed therein.
6. The promotion of the officer(s) as in Para (2) above is subject to the condition that no disciplinary/vigilance case of the types referred to in the Department of Personnel and Training OM No. 22011/4/91-ESTT. (A) Dated 14.09.1992 is pending against them and such case, if any, be referred to the Directorate, and no promotion be made. Further, if in respect of any officer some punishment like stoppage of increment etc. is current, he/she should not be promoted/ relieved on promotion and his/her case should be reported to this office immediately.
7. In respect of Reserved Category candidates i. e. SC/ST candidates "Promotion of the candidates is provisional subject to verification of their caste status. Head of the office will take an undertaking from the officers to this effect at the time of their relieving and ensure verification of caste status within one month. After verification necessary entries may invariably be made in the Service Books of the officers concerned in terms of instructions contained in DO P&T O.M. No. 36011/16.80-Estt.(SCT) dated 27.2.81, No.42012/8/87-Estt.(SCT dated 14.10.87 and O. M. No. 36012/36(22)/89-Estt.(SCT) dated 16.6.89."
