3. Heads of the Postal Accounts Offices/ CCAs will communicate these orders and the place of posting to the officer(s) concerned immediately and obtain from them their acceptance of the offer of promotion within 10 days of the receipt of this memorandum and forward the same to this office. Acceptance of the offer includes the acceptance of the place of posting and no representation for change of place of posting will be entertained and no representation(s) needs to be forwarded. The officers may be relieved immediately by the authorities concerned to report for duty on promotion at the place of their posting except in case of Sl. No. 7 of transfers and Sl. No. 14 of the promotion.

4. Posting within the circle will be made by the Head of the Postal Accounts Office/CCAs concerned.

5. Refusal for promotion is subject to consideration by the appointing authority. If the same is not acceptable, the promotion may be enforced again. If the same is still refused, then even disciplinary action can be taken against the officer for refusing to obey the orders of the competent authority. Cases where, such refusals of promotion/deemed refusal made by the officials have been considered by the appointing authority, then they would automatically be placed under embargo for a period of one year as under:-

i) In case of refusals received within one month, from the date of application declining the promotion.

ii) In all other cases, on the expiry of one month from the date of issue of these orders.

Such officer(s) will not be promoted on adhoc/officiating basis till the expiry of period of embargo.
