ORDER



6. In case the officers are officiating on local arrangement basis in JTS/STS, they would stand reverted to the substantive grade for one working day before assuming charge in JTS Gr. "A" in terms of this order.

7. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.9.92 is pending against the officer or some punishment like stoppage of increment is in currency, he should not be relieved on promotion and the matter should be reported to this office immediately.

8. Most of the officers are being posted/retained at their present stations against overall strength of JTS posts except some cases of administrative need and personnel ground/request due to pandemic situation of COVID-19 and movement restrictions as per the MHA instructions.
