2. The officers promoted on adhoc basis vide this office memo nos. 2-15/2007-PACE/4217-4330 dated 16.03.2010 and 2-15/2007-PACE/4433 to 4373 dated 19.03.2010 will stand reverted to their substantive post of Accounts Officer on 29.06.2010 afternoon before their regular promotion to Sr. Accounts Officer cadre.

3. On promotion to the post of Senior Accounts Officer (Group 'B') their pay will be fixed under FR 22-I (a) (1) (old FR 22-C), with reference to their pay in the cadre of Accounts Officer. The Officers may exercise the option for fixation of their pay on promotion within one month as provided under FR-22.

4. There will be no period of probation in this grade.

5. Vigilance clearance in terms of para 2 of DO&T OMNo.22011/4/91-Estt (A) dated 14.9.1992 may be obtained from the concerned Circle/Unit where the Accounts Officers are presently working and in case any of the Accounts Officer fall under category of para 2 of the aforesaid O.M., need not be promoted and case be referred to Directorate immediately. Particulars of the vigilance case pending may also be intimated to this office.

6. "In respect of Reserved Category candidates i. e. SC/ST candidates, promotion of the candidates is provisional subject to verification of their caste status. Head of the office will take an undertaking from the officers to this effect at the time of their promotion and ensure verification of caste status within one month. After verification necessary entries may invariably be made in the Service Books of the officers concerned in terms of instructions contained in DO P&T O.M. No. 36011/16.80-Estt.(SCT) dated 27.2.81, No.42012/8/87-Estt.(SCT) dated 14.10.87 and O. M. No. 36012/36(22)/89-Estt.(SCT) dated 16.6.89."

7. Promotion orders based on this OM may be issued immediately and communicated to all concerned including the officers concerned and further action be taken.
