

2. The officers at sl No.1 to 3 have been granted notional promotion to Sr. AO cadre w.e.f.30.01.2013 with actual benefit w.e.f. 01.04.2015 or from date of actual joining , whichever is later.

3. The officers already officiating in Sr. Accounts Officer cadre on local officiating basis, if any, may be reverted to the cadre of Accounts Officer before promotion to the cadre of Sr. Accounts Officer(s) on regular basis.




4. On promotion to the post of Senior Accounts Officer (Group 'B') their pay will be **fixed under FR 22-I (a) (1)**, with reference to their pay in the cadre of Accounts Officer. The Officers **may exercise the option** for fixation of their pay on promotion within one month as provided under FR-22.
5. There will be no period of probation in this grade.
6. Vigilance clearance in terms of para 2 of DOP&T OMNo.22011/4/91-Estt (A) dated 14.9.1992 may be obtained from the concerned Circle/Unit where the Accounts Officers are presently working and in case any of the Accounts Officer fall under category of para 2 of the aforesaid O.M., need not be promoted and case be referred to Directorate immediately. Particulars of the vigilance case pending may also be intimated to this office.
7. **"In respect of Reserved Category candidates i. e. SC/ST candidates, promotion of the candidates is provisional subject to verification of their caste status. Head of the office will take an undertaking from the officers to this effect at the time of their promotion and ensure verification of caste status within one month. After verification necessary entries may invariably be made in the Service Books of the officers concerned in terms of instructions contained in DO P&T O.M. No. 36011/16.80-Estt.(SCT) dated 27.2.81, No.42012/8/87-Estt.(SCT) dated 14.10.87 and O. M. No. 36012/36(22)/89-Estt.(SCT) dated 16.6.89."**
8. Promotion orders based on this OM may be issued immediately and communicated to all concerned including the officer's concerned.
9. Charge report should be submitted to all concerned including Sr. Accounts Officer (PA-Admn), PA Wing, Dak Bhawan, New Delhi.
