3. Transfer of the officers mentioned at Sl, No. 1,2,4,5&6 of para 2 above is at their own request and cost hence the officers are not entitled to TA/TP.

4. The Order regarding specific place of posting in respect of officers allotted to DoP would be issued by DDG (PAF), DoP Hqrs.

5. The promotion to the Senior Time Scale of the officers is purely on ad hoc and temporary basis and will not bestow any claim on the officers for regular promotion to the STS nor will the services rendered in the Senior Time Scale count for purpose of seniority in the grade and for promotion to the next higher grade.


6. The local officiating arrangement made in STS, if any, in the case of above said officers should be terminated before promoting them to STS (Ad hoc) in terms of this order.

7. The promotion of the officers is further subject to the condition that no disciplinary/vigilance case is pending against the officers. In case any disciplinary/vigilance case of the type referred to in DOP&T OM dated 14.9.92 is pending against the officer or some punishment like stoppage of increment is in currency, he should not be promoted and the matter should be reported to this office immediately.

8. The pay of the officers on promotion to the grade of STS as above will be fixed under FR 22-(I)a(1) read with FR-35 with reference to their pay in the substantive grade.

9. The Head of the offices should ensure that the officers are relieved promptly. The officers promoted in this order must join their new place of posting within 40 days from the date of issue of orders. If they fail to join at the new posting, it will be presumed that they are not interested in ad hoc promotion and in that case the orders shall be deemed to have been cancelled without any further communication. In such cases the action will be taken as per extant instructions and also no such officer shall be given local officiating promotion in the grade.
